My constituent and friend, Tebabu Assefa, will be leading the discussion on the positive social consequences that Benefit Corporations, or "B-Corps," are having on American society and commerce. Mr. Assefa is a leader in the Ethiopian diaspora community in the U.S. and has been recognized by the Obama Administration as a "Champion of Change" because of his founding and stewardship of Blessed Coffee, a benefit corporation that partners with more than 300,000 small coffee farmers in Ethiopia to create a successful coffee business in America which constantly reinvests in both American and Ethiopian communities.

In 2010, Maryland became the first state to enable businesses to register as Benefit Corporations. Today, more than 30 states have followed suit. Benefit corporations are for-profit businesses that declare in their articles of incorporation a commitment not just to making money but to creating a specific "positive social impact," such as advancing adult literacy efforts or bringing a local stream back to life. B-Corps are showing that businesses can be profitable for private purposes and socially beneficial for larger public purposes at the same time. The Benefit Corporation designation, which obliges companies to abide by the highest standards of social and environmental conduct and to file regular reports on their progress, sends a powerful message to shareholders, employees, business partners and consumers that the company has a commitment not simply to shareholder profits but to larger community purposes as well.


